Simplification of Procedure—Rooftop Solar Program Phase-II (MNRE)

Reference:

- MNRE Office Memorandum titled "Simplification of Procedure—RooftopSolar Program Phase-II", dated June 10, 2022
- SE/SO, DHBVN, Hisar office Memo No. Ch-190/SE/SO-1066 dated 21.12.2022 vide which simplified procedure w.r.t Rooftop Solar Program Phase-II (MNRE) was notified.
- MNRE D.O. letter 318/6/2022-GCRT dated 14.02.2023 vide which it is clarified that the PBG of Rs. 2,50,000/- (Rupees Two Lakh Fifty Thousand Only) will be applicable for the entire area of the DISCOM.

The Ministry of Renewable and New Energy has notified simplified procedure for increasing solar energy through rooftop solar (MNRE Office Memorandum titled "Simplification of Procedure-Rooftop Solar Program Phase-II", dated June 10, 2022 -Annexure-I).

National Portal, <u>www.solarrooftop.gov.in</u> has also been launched by the MNRE for processing RTS applications and releasing subsidies into residential consumers' (beneficiaries') bank accounts following plant installation and inspection.

In view of the guidelines issued by MNRE under the simplification procedure for registration of vendors, Agenda Item No. 302.03 was put up before the WTDs of Nigam & the same was considered & approved by the WTDs of Nigam in their meeting held on 01.12.2022. Accordingly, Simplification of Procedure—Rooftop Solar Program Phase-II (MNRE) was earlier notified vide memo No. Ch-190/SE/SO-1066 dated 21.12.2022.

Subsequent to the above notification, further communication has been received from MNRE vide D.O. letter 318/6/2022-GCRT dated 14.02.2023 and the same was put up before the management of Nigam.

After having considered the same, further concurrence in this regard has been accorded by the management and accordingly the following revised procedure is being notified, in supersession to the earlier notification issued in the matter, for its adherence and meticulous compliance in letter & spirit:-

- 1. The vendors willing to empanel/register have to submit an application at Circle level along with a declaration, (as per **Annexure-II)** in the DISCOM.
- 2. The vendors have to deposit a PBG of Rs. 2,50,000/- (Rs Two Lakh Fifty Thousand only) valid for at least five years in the format enclosed as **Annexure-III**.

3. The registration of vendors will be initially for one year from the date of empanelment and can be renewed thereafter on a yearly basis based on their performance.

4. The vendors who are empanelled through EOI No. 2/CE/C/2022 & have submitted their PBG with the validity of 5 years will be considered automatically empanelled for the simplified procedure.

The list of such eligible vendors is enclosed as Annexure-IV.

5. The subsidy available under the simplified procedure will be the same for beneficiaries all over the country. The notification issued by MNRE w.r.t the CFA/Subsidy available for applications registering till 31.12.2023 in the National Portal is enclosed as Annexure-V.

6. Under the National Portal, MNRE has clarified (Annexure-VI, FAQs) that the project cost would be mutually decided between the vendors and consumers and DISCOM has no role in terms of

rate discovery and finalization of project cost.

7. Vendors should not be 'Black Listed / suspended /barred' by any Utility / any State / Central Govt., Department / PSUs, nor should have any pending 'Litigation' proceedings. An affidavit to this effect by the authorized signatory, on NJSP of minimum denomination of Rs. 100, duly attested & registered by the NOTARY shall be required to be submitted by the vendors along with the application.

- 8. SE/Ops at circle offices shall be the Nodal for the empanelment of the vendors under Simplified Procedure for RTS. Vendor shall have the choice to submit the application (along with the required documentation) to any Circle Office as per his / her convenience addressing the same to Nodal in-charge. Circle Office will review the applications in accordance with the instant notification issued in this regard by DHBVN titled "Simplification of Procedure-Rooftop Solar Program Ph-II and shall further notify the empanelment of the vendor(s). Thereafter, the PBG of Rs. 2,50,000/- (Rupees Two Lakh Fifty Thousand Only) shall be submitted by such vendor(s) to the notifying Circle office and accordingly empanelled vendor/(s) shall be allowed to work in the entire area of DHBVN.
- 9. On receipt of the valid PBG, the Circle Office will immediately notify the same to the SE/SO, DHBVN, Hisar (Nodal office for RTS) and S.E./I.T., DHBVN, Hisar for updating the name of the vendor(s) on the National Portal/e-solar portal.

The validity of the above scheme is upto 31.03.2026 or until further notification from MNRE. However, the CFA/subsidy applicable for projects installed through the National Portal would be subject to annual revision (calendar year).

SEs/Operations are requested to ensure wide publicity of the "Simplification of Procedure-Rooftop Solar Program".

Any reference to the provisions of the subject cited matter and conditions of procurement, as notified by MNRE & Nigam from time to time, shall be construed as reference to the instant notification.

Subject: Simplification of Procedure - Rooftop Solar Programme Ph-II.

This is in continuation of this Ministry's OM of even no. dated 02.02.2022, vide which simplification of procedure for installation of residential grid connected rooftop solar plants was conveyed.

- 2. In this regard, a National Portal, www.solarrooftop.gov.in, is being designed and will be launched soon. The process for installation of rooftop solar plants, starting from registering the applications to release of subsidy in residential consumers' (beneficiaries') bank account after installation and inspection of plant, can be tracked online at the national portal.
- 3. In order to protect the interests of beneficiaries and ensure that the vendors installing the rooftop solar plants have the requisite expertise, follow minimum specifications and standards specified by the Ministry and maintain the plant for at least five years from the date of installation, it has been decided that such vendors have to register/empanel themselves with the beneficiaries' Distribution Utility (DISCOM).
- 4. The vendors currently empanelled with the beneficiaries' DISCOM through tendering process under RTS Programme Ph-II will be considered as empanelled vendors for this purpose. Other vendors willing to register/empanel themselves in the Programme under simplified procedure may get themselves registered with the consumers' DISCOM by submitting an application along with declaration (as per Annexure) and depositing a PBG of Rs. 2,50,000/- (Rupees Two Lakh Fifty Thousand only) valid for at least five years. The vendors can submit the application at the Division/Circle level and the name of the vendor will be included in the list of registered/empanelled vendors within a period of one month from the date of submission of the application. Registration/empanelment of vendors will be valid initially for one year from the date of empanelment and can be renewed thereafter on yearly basis. The DISCOM will notify the registered/empanelled vendors on its website for information of residential consumers and update the same every month.
- 5. The registered/empanelled vendor selected by the beneficiaries will conduct the physical survey to assess the RTS capacity and guide the beneficiary on the RTS capacity that can be installed in the beneficiary's premises considering technical and financial parameters. The vendor shall also provide assistance to the beneficiary in getting necessary approvals, installing the net-meter and facilitating inspection by the DISCOM.
- 6. In case of any misleading information is provided by any vendor or conditions mentioned in the declaration are not met, the DISCOM will take action against the registered/empanelled vendor including blacklisting and forfeiture of PBG.

- 7. The subsidy available under the simplified procedure will be the same for beneficiaries all over the country. The rates of subsidy will be notified for each calendar year and will be applicable for all beneficiaries who have registered their application on the national portal during the calendar year.

Subject: Admissibility of CFA for residential sector rooftop solar projects installed under Rooftop Solar Programme Phase-II

Ministry is implementing Rooftop Solar Programme Phase-II inter-alia providing Central Financial Assistance (CFA) for installation of Rooftop Solar (RTS) in the residential sector. The Programme is being implemented by DISCOMs/State Implementing Agencies.

- 2. National Portal (https://solarrooftop.gov.in/) for Rooftop Solar was launched on 30.7.2022. On the National Portal any residential consumer from any part of country can apply for installation of RTS and get CFA directly in his/her bank account. All the steps starting from application to release of CFA can be monitored by consumer online on the Portal. In the National Portal the CFA amount for the RTS capacity installed by a consumer is common for entire country which is as under:
 - i. Individual Household For first 3 kW: Rs. 14588/ kW and for RTS capacity beyond 3 kW and upto 10 kW: Rs. 7294/kW.
 - ii. Resident Welfare Associations/Group Housing Societies (RWA/GHS) Rs. 7294/kW for common facilities up to 500 kWp @ 10 kWp per house.
- 3. Ministry has got representation for providing higher CFA through National Portal in line with higher benchmark cost prescribed for North Eastern States and hilly States/UT. The request has been considered by Ministry and it has been decided to provide higher CFA for residential consumers of North Eastern States including Sikkim, Uttarakhand, Himachal Pradesh, UT of Jammu & Kashmir, Ladakh, Lakshadweep, and Andaman & Nicobar Islands. All residential consumers of these states/UTs applying for installation of rooftop solar on the National Portal for Rooftop Solar on or after date of issuance of this OM will be eligible to get higher CFA as mentioned below.:
 - i. Individual Household For first 3 kW: Rs. 17662/ kW and for RTS capacity beyond 3 kW and upto 10 kW: Rs. 8831/kW.
 - ii. Resident Welfare Associations/Group Housing Societies (RWA/GHS) Rs. 8831/kW for common facilities up to 500 kWp @ 10 kWp per house.

- 4. Ministry has also got representation from various stakeholders that presently two modes are being implemented in parallel. One is rates discovered and vendors empanelled by DISCOMs/SIAs through tendering process and other National Portal for Rooftop Solar. These two modes are creating confusion amongst consumers mainly due to difference in CFA rates. After having careful examination and to avoid ambiguity, it has been decided that uniform and fixed CFA as applicable under simplified procedure will be applicable for both the implementation modes. Therefore, for the all the future bids and the bids which are scheduled to be closed after 15 days of the issuance of this OM by the DISCOMs/SIAs against the capacity allocated by Ministry for installation RTS in residential sector under Rooftop Solar Programme Ph-II, the uniform and fixed CFA as applicable under National Portal for Rooftop Solar will be applicable.

Frequently Asked Questions on Simplified procedure for installation of rooftop solar (RTS) projects

Q. Basic information of grid connected rooftop solar PV system and MNRE scheme?

A. Refer FAQs at https://solarrooftop.gov.in/pdf/faq_new.pdf

Q. What is simplified procedure for installation of rooftop solar PV system?

A. In addition to the existing procedure of tendering/empanelment by the state electricity distribution companies (DISCOMs), MNRE has introduced a simplified procedure through which the beneficiaries can install the rooftop solar project either by themselves or through any vendor of their choice. Under this procedure, it will not be mandatory for the beneficiary to install the project only through the vendors empanelled by the DISCOMs. The beneficiary will have to apply online at the National Portal for installing the RTS system and the subsidy/CFA will be transferred to the bank account of the beneficiary directly after successful installation of RTS project.

Q. What is the National Portal (NP)?

A. MNRE has developed a 'National Portal (NP)' for the registration of applications under the simplified procedure. The whole process from submission of application to the release of subsidy/CFA would be implemented in online mode through this portal. The portal can be accessed through the link

Q. How can I register on National Portal (NP)?

A. For registration at NP, the applicant will need electricity bill, an active 10-digit Mobile number and an active E-mail ID. The consumer will also be required to download SANDES App on his mobile. First, the applicant has to visit the registration page of national portal and select the state and the concerned DISCOM. Then the applicant has to enter consumer account no. mentioned in the electricity bill, mobile number and mail id. After entering this details, an OTP will be sent through SANDES App for mobile number verification. On successful verification of the mobile number, an account activation link will be received on the mail-id provided. The activation link will also include the details of the simplified procedure. After clicking on the activation link received in the email, the account would be activated and the beneficiary will be redirected to NP for submission of application.

Q. Is there any application fee for applying on NP?

A. No, there is no application fee for submission for application on national portal. However, there may be fees for net-metering which may be charged by the respective DISCOMs.

Q. Is there any difference in subsidy/CFA in both modes i.e. DIY or DISCOM empanelled Vendors?

A. Yes there can be difference in subsidy/CFA. The subsidy/CFA available for the applicant under respective modes would be displayed to the applicant during the application stage.

Q. Can I apply for net-metering through NP?

A. Yes. An applicant can apply for net-metring and inspection through the national portal. The application process of NP has been uploaded on the portal.

Q. What bank details are required for the release of subsidy through NP?

- A. After receipt of the online commissioning/completion report from DISCOM, the applicant will have to enter following details for claiming subsidy/CFA:
 - Name of the beneficiary
 - Account number
 - Bank Name
 - IFS Code
 - Copy of cancelled cheque to be uploaded on the portal
- Q. How can I raise a complaint/grievance, in case of non-receipt of subsidy amount in a given time?
- A. You need to raise a complaint under the grievance section on NP.
- Q. What would be the cost of the system charged by the vendor under simplified procedure?
- A. Under simplified procedure, the cost of the system would be mutually decided by the consumer and the vendor. However, the consumer can get idea of the prevailing market rates of the RTS system through benchmark cost issued by MNRE and the cost discovered in the different states.
- Q. How can I ensure quality of the system installed by the vendor?
- A. MNRE has issued technical standard and specification for various components of RTS plant. The consumer shall sign an agreement with the vendor that the installation and commissioning of the RTS system would be in accordance with the technical standards and specifications issued by MNRE. MNRE has prepared a model agreement and the same can be adopted by the consumer.
